Speaking Up for Consciousness / Plaider pour la conscience

I will outline a conception of phenomenal consciousness, and present an argument that it is important in the following respects. It accounts for our warrant for first-person "introspective" judgments; it is essential to mind; and it figures crucially in the irreplaceable value accorded persons as well as in our empathetic regard for others.

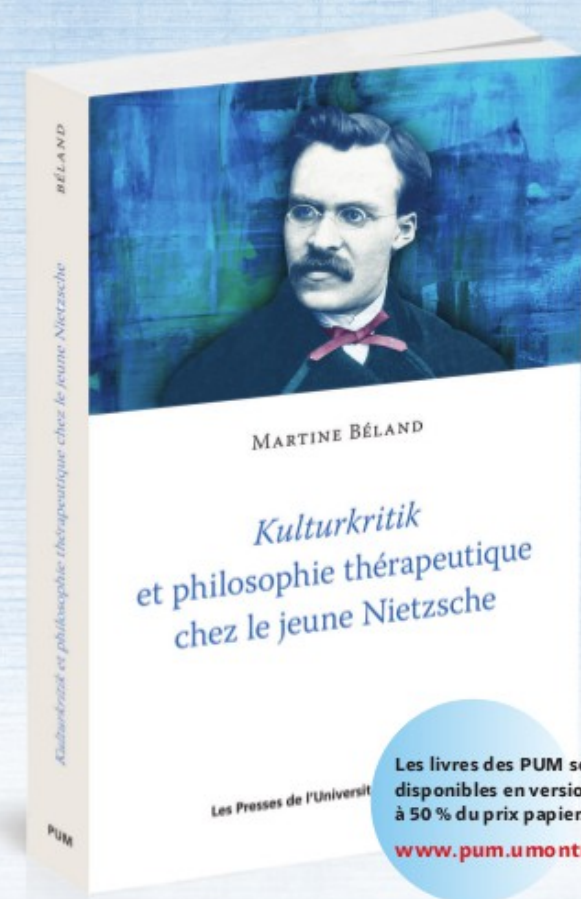
